# Fees:

Entry fee is \$15.00 for the first event each <u>individual event</u> and \$10.00 for each <u>additional event</u>. Entry fee will not be transferred or refunded after June 17, 2012. <u>Entries will not be processed unless the entry fee is received with this form or signed electronically. Bring a legible copy of a birth certificate or proof of age along with a USATF membership card if your age has not been verified on USATF records.</u>

# Eligibility:

This meet is open to all Masters (including Sub-Masters 30-34) and Open athletes (19-29) who are 2012 USATF registered athletes. USATF memberships can be obtained through your Association Membership Chair (<a href="www.usatf.org/associations">www.usatf.org/associations</a>) or online (<a href="www.usatf.org/membership">www.usatf.org/membership</a>). <a href="mailto:Mon USATF cardholders are ineligible to participate in this, the Illinois Association Masters and Open Championship, event">www.usatf.org/membership</a>). <a href="Mon USATF cardholders are ineligible to participate in this, the Illinois Association Masters and Open Championship, event">www.usatf.org/membership</a>). Age divisions are determined by year of birth on the day of the competition. Athletes must compete in their true age divisions. NO MOVING UP OR DOWN.

# Entries:

Attached are entry forms. Completed entry forms must be received by Monday, June 17<sup>th</sup> at midnight. Appropriate registration fees must accompany the application form. If an entry is late, a late fee of \$10.00 is applicable. Entry forms should be mailed to the office as follows:

# Check-In Requirements:

*Bib n*umbers will be provided at packet pick-up for all athletes. Be sure to bring birth certificates and USATF membership cards when you pick up packets.

# Awards:

Individual USATF event awards will be awarded to participants who finish 1<sup>st</sup> - 3<sup>th</sup> place in each individual Association Championship event. There will be no awards for the relay participants.

# Officials:

Anyone desiring to officiate at this meet is encouraged to contact the Officials Chair, Win Eggers or Jamero Rainey.

# Facility:

Spikes up to but not exceeding  $\frac{1}{4}$ " will be allowed. Your cooperation will be appreciated. Fully Automatic Timing is expected to be present on the date of the competition. **No radios, glass containers, smoking, tobacco, or alcoholic beverages are allowed in the facility.** Full concessions are available on site.

# Equipment:

There will be starting blocks but athletes are expected to bring their own. Field event athletes are expected to bring their own implements. Weighing of implements will take place at registration.

# FROM THE NORTH/NORTHEAST

Take Interstate 57 South to exit #312. Turn Right on to Court Street continue for 2 ½ miles west on Court Street to Curtis Ave, Turn Left there is a Phillips 66 on the corner going South for 1 mile to Jeffery St. Turn Left then a quick Right in to the school.

# FROM THE SOUTHWEST/I-55 SOUTH

Take Rt. 17 East from Dwight to Kankakee. Rt. 17 becomes Court St. Turn Right on to Curtis Ave, going south to Jeffery St. Turn left then a quick Right into the school.

# FROM THE NORTHWEST/I-55 NORTH

Take I-55 to I-80 east, I-80 east to I-57 south to exit #312. Turn Right on to Court Street continue for 2 ½ miles west on Court Street to Curtis Ave, Turn Left there is a Phillips 66 on the corner going South for 1 mile to Jeffery St. Turn Left then a quick Right in to the school.

# FROM THE NORTHWEST I- 355 SOUTH
