- 7. New LDR chairman is Greg Evans. Greg is putting together a clinic for coaches.
- 8. Dorothy thanked Art Paul and Lee Slick for their hard work.
- 9. Dorothy advised that as far as can be determined, Illinois received \$1200 for 2005 Junior Olympics.

Lorette Cherry covered the following:

- 1. Club memberships are due by May 1st. After May 1st, there is a \$100 late fee.
- 2. Travel grants deadline is May 1st.
- 3. Presented award to all 2005 (YA, JO, JO X-country) 1st place finishers. Next year we will plan an awards luncheon sometime in the January/February timeframe. Volunteers are needed to organize.

Diane Graham-Henry (Race Walk)

- Hosting national junior elite race walkers camp in Chicago in June.
- Pat Savage is hosting the DePaul Relays at Lane Tech on May 14th.

Win Eggers – (Official)

- New certification for four years starting September 1.
- Re-certification requires a resume that includes a list of USATF meets and personal membership.
- Officials insurance.
- Letters going out in October & November to re-certify.
- Must have officiated at three USATF meets.
- There is a revised test (50 questions) that is good for four years.

- State meet will be held at Kankakee High School:
 - i. Hammer will be contested on Friday.
 - ii. Race walking will be contested on Saturday.
 - iii. 5000/3000 will be contested on Sunday.
 - iv. Protest fee is \$100.
 - v. Two gates: (1) Athletes and coaches and (2) spectators.
 - vi. Coaches are encouraged to get their athletes to the hipping and clerking area on time.
