In 2009 the National Youth Championships will be held June 30-July 5, 2009 in Ypsilanti, Michigan. The National Junior Olympics Championships will be held July 28-August 2. 2009 in Greensboro. North Carolina. The National Junior Olympic Cross Country Championships will be held in Reno. Nevada. December 12, 2009. You can always go online at

www.usatfillinois.org for all meets in 2009.

USATF Illinois won the bid to host the 2010 Youth National Championships to be held at Benedictine Univ. in Lisle, IL. The National Junior Olympic. Championships Outdoor meet is to be held in Sacramento, CA., and the National Junior Olympic Cross Country Championships will be held in Hoover, Alabama.

The trials for the 2009 International Youth team will be held in Ypsilanti, MI prior to the start of the 2009 National Youth Championships. If you plan to participate in this meet, you must have an updated passport before June, 2009. They will be selecting the 1<sup>st</sup> & 2<sup>nd</sup> place winners that meet the IAAF standards. If you are chosen for the team, you will be leaving for Italy one week after the trials.



We are asking our coaches, officials, parents, and senior citizens to volunteer to work at our meets, especially the State and Regional meets. In addition I would like all coaches who might be interested in working and traveling with one of the international youth teams, to please send me a detailed resume. As soon as I receive it, I will get it to the committee that will evaluate it.

This year we are fighting to get all peewee/pre-bantams, to be allowed to qualify for the National Youth and Junior Olympics meets. It is imperative that our entire teams qualify and participate in all national meets. Our Youth Executive Committee meets in Detroit, Michigan, March 20 - 22.
